USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horse used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage
Sport Horse Breeding classes.

RULES AND REGULATIONS

Entries The closing date for entries for Louisiana Spring Classics is **Wed. April 10, 2013.** After that date stall fees are nonrefundable. Entries should be sent to address on entry blank. Checks are to be payable to Louisiana Spring Classic. No horse may participate in the event or be on the grounds without having a completed entry blank, including signatures acknowledging the agreement printed thereon. Horse show management is not responsible for entry errors due to incomplete or illegible entry forms. If one wants points to count toward end of the year award, the owner's, horse's, and rider's USEF member numbers must be on the entry form. Owners and exhibitors are responsible for all horses and fees incurred by them or their agents, even though payment may not be submitted with entry. Parent or legal guardians of minor exhibitors will not hold Elite Show Jumping, Inc., staff, or facilities responsible for any injury to such minor. No minor's entry will be accepted without the signature of a parent or legal guardian. Entry forms for each show must include horse's name, rider's name, all classes or divisions entered, ALL MANDATORY SIG-NATURES, and Social Security or Federal ID numbers of owners. Current negative Coggins tests are required for admittance to the grounds. Entries received after the closing date of 4/10/13 will incur an additional fee of \$50.00 per horse. Refunds are given to entries with cancellation prior to the show, less a \$15.00 processing fee. A \$30.00 fee will be charged for returned checks. Upon notification, accounts will be given (5) five days to be paid in full. If not made agreeable in five days, sanctioning organizations will be notified for disciplinary repercussions. Additional fees such as a \$25.00/per day non-stabling fee or a \$50.00 non-showing fee will apply to those applicable. Both non-stabling horses and non=showing horses are expected to pay office and medic fees. Upon leaving an open signed check, exhibitors will receive their numbers. Any horse show bills not checked out at the conclusion of each show will be checked out by the horse show secretary. Any mistakes at check out must be resolved within 24 hours. Please check your bills carefully. Current USEF rules relating to drugs and medications will be enforced. Each horse entred must pay the \$8.00 USEF Drug/Medication Fee plus an \$8.00 USEF fee. (Total \$16.00 USEF Fee). Each horse entered will also be required to pay the USHIA Zone Support fee of \$2.00. **Credentials** ALL EXHIBITORS IN ANY PONY, JUNIOR HUNTER OR AMATEUR SECTION MUST PRESENT THEIR CREDENTIALS (MEASUREMENT CARD OR AMATEUR CERTIFICA-TION) TO THE SHOW OFFICE BEFORE THEIR NUMBERS CAN BE RELEASED. Kindly send a photo copy of credentials with entry to facilitate processing. All horses or ponies without a valid measurement card will be measured at a designated time and place. Anyone not presenting valid membership credentials (USEF/USHJA) will charged a \$30.00 nonrefundable non-member fee per organization. Amateur exhibitors not able to present valid Amateur Credentials will be required to pay the \$30.00 annual Amateur Card fee. Only a parent will be exempt from the Federation non-member fee if signing as coach for his/her minor child.

Horse Registrations All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR091.9, items 1-9) must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions in order to receive a number. Motor Homes A limited number of motor homes and camper sites are available. Please contact 404-518-9198 prior to mailing entries for camper reservations. \$175 weekly fee.

RULES AND REGULATIONS

Stabling and Bedding_ 300 10x10 permanent stalls with doors are \$200. There will be a discounted rate of \$175 if paid in full by closing date. To receive the discounted rate of \$185 for horse and tack stall an entry blank for each week must be completed in full and payment *received prior* to closing date of April 10, 2013. One horse/pony per stall. There will be no sharing of stalls. Shavings deliveries need to be made through the horse show office. There will be no Sunday deliveries. Trainers or agents need to check in with the horse show secretary to verify shavings count and stall splits.

Motorized Vehicles/Golf Carts Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be premitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid drivers license. The parent(s), guardian(s) or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be caused for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s) and/or trainer(s) from competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and mobility assistance devices for individuals with disabilities are exempt from this rule.

<u>Protective Headgear</u> Protective head gear, properly secured, must be worn **BY ALL RIDERS AT ALL TIMES WHILE MOUNTED**, ANYWHERE, ANYTIME ON THE SHOW GROUNDS. Headgear for **all riders** must meet or exceed ASTM Standards; must carry the SEI tag; and be properly secured by a harness per USEF rules.

Conduct Any act of discourtesy to a Judge, Show Official, or staff member on the part of any trainer, owner, rider, or groom will immediately disqualify any horse with which they are associated and all entry fees will be forfeited. No refunds will be made.

Schooling Schooling in the show rings without permission is prohibited at all times. Rings will be available for ticketed warm-up the day prior to the show. The rings will be available after the show for one hour each day and for limited schooling in the morning before the show. There will be no schooling over fences in the morning of the shows. Gate personnel have the authority to scratch riders who do not follow directions. Management may restrict schooling if conditions warrant.

Schooling Rings are off limits to horses not entered in show in the current week. All horses on grounds must have a current entry blank in the office and be entered in the show.

Poling and Off-sets Manual poling and the use of bamboo off-sets are prohibited for all horses competing. Any rider, trainer, groom, or other person involved with poling or off-setting will be subject to a \$500 fine.

Lunging Lunging will be restricted to designated areas. There will be no lunging in show rings or schooling rings.

Attire Jackets will be worn for hunter and equitation classes. Tucked-in polo shirts can be worn in the jumper ring. For classics and medals, formal attire is required. In extremely warm conditions, for the safety of our competitors, jackets will be waived.

Dogs All dogs must be on leashes in agreement with state and local laws. Unrestrained dogs are a safety hazard for exhibitors and their horses. Doug owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards pursuant to rule GR 301. Dogs that are loose are subject to impound and a \$100 fine.

Electrical/Fire Regulations All electrical installation and connections must meet all state and county codes. Aisles shall be maintained clear for a minimum of six feet wide by eight feet high. No obstructions or projections shall be allowed in these aisles. No ClassI Flammable liquids such as gasoline are allowed inside the buildings. Cooking is not permitted within the stable area. Anyone found in violation shall be subject to dismissal from further participation in the horse show without recourse. "Every class offered herein which is covered by the rules and specifications of the current USEF Rulebook



Children's Hunter:

To be ridden, and handled in all phases of competition, by Junior exhibitors. Open to horses and ponies. State rules may prohibit entry of ponies (see exception paragraph below). Cross Entry: The same rider/horse (pony) combination may not compete at the same competition in any class (equitation and USHJA National Hunter Derby excepted) in which fence heights exceed 3'3. The rider may compete on a different horse or pony at the same show in any other division or section for which the rider/mount are eligible. The horse or pony may be shown by a different rider in any other division or section at the same show except Junior Hunter or a different age group in Children's Hunter. Exception: A state association may adopt more (but not less) restrictive cross entry rules (see below). Course and Judging Specifications: Fence height: 3' or 3'3", spread not to exceed fence height. Courses will not be adjusted for ponies. To be judged on performance, soundness, manners, way of going, and suitability of mount to rider. Entries are not required to jog for soundness. The Adult Amateur, Children's Hunter sections and Children's Hunter Pony may be combined if there are less than four in any of these sections. One award will be offered for both sections.

Children's Hunter Pony:

Open to ponies ridden by a Junior Exhibitor with no other age restrictions applicable. Rider and/or pony may enter any Equitation classes. The rider may compete on a different horse or pony at the same competition in any other division or section where the jumps do not exceed 3'. To be judged on performance, soundness, manners, way of going, suitability of size of rider to mount, and suitability as a Children's Hunter. Ponies not required to be jogged for soundness. Small ponies to be shown at 2', Medium Ponies at 2'3", and Large Ponies at 2'6"; spreads not to exceed height of fence The Adult Amateur, Children's Hunter sections and Children's Hunter Pony may be combined if there are less than four in any of these sections. No minimum prize money is required.

Pre-Green:

Refer to HU106.3. Zone awards to be offered at each height section.

Adult Amateur Jumper:

To be ridden by Amaleurs who are no longer eligible to compete as Junior Exhibitors. Cash winnings do not influence this classification.

Children's Jumper:

To be ridden by Junior Exhibitors. Cash winnings do not influence this classification.

Class Conditions for Adult Amateur and Children's Jumper:

Classes in the Low Adult Amateur and/or Children's Jumper section will be conducted at 1.0 m (3'3'') to 1.05 m (3'5''). Classes in the High Adult Amateur and/or Children's Jumper section will be conducted at 3'6'' or 1.10 m (3'7'') to 1.15 m (3'9''). If only one section is offered, the classes will be conducted at 1.10 m for all classes offered in the section. Competition Management may restrict cross entries between High and Low sections at the same show if stated in the prize list. Classes to be scored under Table I, Table II, Section 1, Sections 2(a), 2(b), 2(c), or 3; or Table IV (Optimum Time). Cross entry into Junior or Amateur Owner Jumper or any class at 1.25 m and above is not permitted for the same horse/rider combination at the same show.
