*Below for all directions above: Stay on S. Fulton Pkwy for 7.5 miles then Right on “Hwy 92 Campbellton Fairburn Rd”. Go 4.5 miles then Left on “Hwy 0 Cascade Palmetto Rd”. Go 0.3 miles then Right on “Cochran Mill Rd”. Go 1 and 1/4 mile, then right into show entrance. From I-20 heading East: Take Exit 37 Hwy 92 Fairburn/ Douglasville; end of ramp go Right on 92 South/ Fairburn Rd. Go 5.2 miles then go Right at light staying on 92 South Fairburn Rd. Go for 4.2 miles then at light go Right on Cascade Palmetto Rd. Go 0.3 miles then Right on Cochran Mill Rd. Go 1/2 mile, then right onto Cedar Grove Road show entrance is 1 and 1/4 mile on the right.

From I-85 heading North: Take Exit 61 Hwy 74, Fairburn; end of ramp go left heading North on 74. When the 4 lane turns into a 2 lane, stay straight (do not continue on 74; go straight for 2.3 miles until the road dead ends into Rivertown. Go left on Rivertown for 3.5 miles to S. Fulton

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and I Elite Shows ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

Under Georgia law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Chapter 12 of Title 4 of the Official Code of Georgia Annotated.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulteur or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of Elite Shows (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status. I acknowledge that I may opt out at any time by going to My USEF Dashboard or calling (859) 810-8733.

Atlanta in the Spring is dedicated to the health, welfare and safety of all exhibitors both equine and human. To protect our equine partners, we will be enforcing the following protocols.

It is advised that all horses stabling on the show grounds arrive between 7:00 a.m. and 6:00 p.m. If it is necessary to arrive at any other time you must check in with the night security officer.

1. A current (within 12 months) negative Coggins test is required.
2. A Health Certificate must be signed by a licensed veterinarian within 30 days of arrival at the Pensacola Summer Series.
3. GR845 Equine Vaccination Rule 1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee
4. Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to Elite Show Jumping management and to the Show Veterinarian. It is always better to err on the side of safety. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.
5. Please take the time to review equine good hygiene practices. Please convey the importance of this to your equine caretakers for their daily routines.

Rules & Regulations

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

Entries The closing date for entries for Winter Fest is **March 8, 2024, after these dates ALL stall fees are nonrefundable.** Completed entries accompanied by check or credit card should be sent to address on entry blank. Checks are to be payable to Elite Shows. No horse may participate in the event or be on the grounds without having a completed entry blank, including signatures acknowledging the agreement printed thereon. Horse show management is not responsible for entry errors due to incomplete or illegible entry forms. If one wants points to count toward end of the year award, the owner's, horses, and rider's USEF member numbers must be on the entry form. Owners and exhibitors are responsible for all horses and fees incurred by them or their agents, even though payment may not be submitted with entry. Parent or legal guardians of minor exhibitors will not hold Elite Shows, Inc., staff, or facilities responsible for any injury to such minor. No minor's entry will be accepted without the signature of a parent or legal guardian. Entry forms for each show must include horse's name, rider's name, all classes or divisions entered, ALL MANDATORY SIGNATURES, and Social Security or Federal ID numbers of owners.

Current negative Coggins tests are required for admittance to the grounds. **Entries received after the closing dates 03/08/24 will NOT be accepted.** Refunds are given to entries with cancellation prior to the show, less a \$15.00 processing fee. A \$35.00 fee will be charged for returned checks. Upon notification, accounts will be given 55 five days to be paid in full. If not made agreeable in five days, sanctioning organizations will be notified for disciplinary repercussions. Additional fees such as a \$25.00/per day non-stabling fee or a \$50.00 non-showing fee will apply to those applicable. Both non-stabling horses and non-showing horses are expected to pay office and medic fees. Upon leaving an open signed check, exhibitors will receive their numbers. Any horse show bills not checked out at the conclusion of each show will be checked out by the horse show secretary. Any mistakes at checkout must be resolved within 24 hours. Please check your bills carefully. Current USEF rules relating to drugs and medications will be enforced. Each horse entered must pay the \$23.00 USEF Drug/ Medication Fee. Each horse entered will also be required to pay the USHJA Zone Support fee of \$7.00.

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste. Individuals found to improperly dispose of needles or other sharp disposable instruments will be fined \$100.00.

No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.

Credentials ALL EXHIBITORS IN ANY PONY, JUNIOR HUNTER OR AMATEUR SECTION MUST PRESENT THEIR CREDENTIALS 5MEASUREMENT CARD OR AMATEUR CERTIFICATION TO THE SHOW OFFICE BEFORE THEIR NUMBERS CAN BE RELEASED. Kindly send a photo copy of credentials with entry to facilitate processing. All horses or ponies without a valid measurement card will be measured at a designated time and place. Anyone not presenting valid membership credentials to either or both The USEF or USHJA will be charged a show pass fee per organization of \$45.00 USEF \$30.00 USHJA . **Only a parent will be exempt from the Federation show pass fee if signing as coach for his/her minor child.**

Horse Registrations All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes 5except those activities enumerated in GR091.9, items 1-9 must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions in order to receive a number.

Motorized Vehicles/Golf Carts Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Conduct Any act of discourtesy to a Judge, Show Official, or staff member on the part of any trainer, owner, rider, or groom will immediately disqualify any horse with which they are associated and all entry fees will be forfeited. No refunds will be made.

Stabling and Bedding 12 x 12 permanent stalls with doors and dirt flooring are \$225 per week. One horse/pony per stall; NO sharing of stalls. Shavings orders need to be made through the horse show office. There will be no Sunday deliveries. Trainers or agents need to check in with the horse show secretary Friday by 2:00 p.m. to verify shavings count and stall splits.

Competition Arenas Jumper Ring—200 X 300 Hunter Rings—150 X 300 . All rings including warm up rings have a sand and fiber footing mixture.

Schooling Schooling in the show rings without permission is prohibited at all times. Rings will be available for warm-up the day prior to the show. There will be no schooling over fences in the morning of the shows. Gate personnel have the authority to scratch riders who do not follow directions. Management may restrict schooling if conditions warrant.

Schooling Rings are off limits to horses not entered in show in the current week. All horses on grounds must have a current entry blank in the office and be entered in the show.

Lunging Lunging will be restricted to the designated area, 150 x 200 area with sand and fiber footing. There will be no lunging in show rings or schooling rings.

Motor Homes A limited number of motor homes and camper sites are available. Please send in RV reservation forms prior to mailing entries for camper reservations. \$275 per week.

Protective Headgear Protective head gear, properly secured, must be worn BY ALL RIDERS AT ALL TIMES WHILE MOUNTED, ANYWHERE, ANYTIME ON THE SHOW GROUNDS. Headgear for all riders must meet or exceed ASTM Standards; must carry the SEI tag; and be properly secured by a harness per USEF rules.

Poling and Off-sets Manual poling and the use of bamboo off-sets are prohibited for all horses competing. Any rider, trainer, groom, or other person involved with poling or off-setting will be subject to a \$500 fine.

Attire Jackets will be worn for hunter and equitation classes. Tucked-in polo shirts can be worn in the jumper ring. For classics and medals, formal attire is required. In extremely warm conditions, for the safety of our competitors, jackets will be waived.

Dogs All dogs must be on leashes in agreement with state and local laws. Unrestrained dogs are a safety hazard for exhibitors and their horses. Dog owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards pursuant to rule GR 301. Dogs that are loose are subject to impound and a \$100 fine.

Electrical/Fire Regulations All electrical installation and connections must meet all state and county codes. Aisles shall be maintained clear for a minimum of six feet wide by eight feet high. No obstructions or projections shall be allowed in these aisles. No Class Flammable liquids such as gasoline are allowed inside the buildings. Cooking is not permitted within the stable area. Anyone found in violation shall be subject to dismissal from further participation in the horse show without recourse.

Reminder : All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S Center for SafeSport training requirement to be eligible to participate in the competition . All participants must adhere to the U.S. Center for Safe Sport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

ELIGIBILITY FOR ADULT AMATEURS: HUNTER, JUMPER, AND EQUITATION: To be ridden by exhibitors who have reached their 18th birthday as of December 1 of the current competition year and who hold a current USEF Amateur certification. Open to horses and ponies.

ELIGIBILITY FOR CHILDREN'S SECTIONS: HUNTER, JUMPER, AND EQUITATION: To be ridden by exhibitors who have not reached their 18th birthday as of December 1 of the current competition year.

ADULT AMATEUR HUNTER

Sections offered and requirements:

- Adult Amateurs – may be split into three (3) sections

Cross Entry:

Rider: Riders in this section may enter any Equitation class and any class where otherwise eligible. Riders who compete in the Amateur Owner Hunter and/or Jumper classes may show other horses that they own in the Adult Amateur Hunters. Riders competing in the Amateur Owner 3'3" section (but not competing in the Amateur Owner 3'6" section) may ride one horse that they do not own in the Adult Amateur Hunter section.

Horse: Horses and ponies exhibiting in this section may cross enter multiple sections of Adult Amateur Hunter and any classes where eligible.

Fence height:

- 3'0" with spreads not to exceed the fence height.
- Courses will not be adjusted for ponies.
- *In and outs* will be permitted.

Combining/Dividing Sections: May be split into three sections:

- Adult Amateurs 18– 35
- Adult Amateurs 36– 49

The Adult Amateur Hunter section may be divided by age of rider and/or height of fences. If there are fewer than three (3) entries in a section, that section must be combined with another Adult Amateur section. The Adult Amateur Hunter section may be combined with the Children's Hunter section when there are fewer than three (3) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Classics: Adult Amateur Hunter Classics

Four (4) entries are required to conduct an Adult Amateur Hunter Classic. If there are fewer than Four (4) entries in any one Adult Amateur Hunter Classic, it may combine with other sections of Adult Amateur Hunters or Children's Hunter Horse. If Adult Amateur Hunter Classics are combined and a horse is shown in more than one section qualifying for the Adult Amateur Hunter Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the Classic.

Adult Amateur Hunter Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

- Adult Amateur Hunter 18- 35
- Adult Amateur Hunter 36- 49
- Adult Amateur Hunter 50 & over

LOW ADULT AMATEUR HUNTER

Eligibility: Open to exhibitors who have reached their 18th birthday as of December 1 of the current competition year.

Cross Entry:

Rider: Riders may not cross enter into any class or section at the same competition where fences exceed 3'3" (Exception: All Equitation classes). Riders who compete in the 3' Adult Hunters and/or the 3'3" Amateur Owner Hunter classes may show horses that they own in the Low Adult Hunters and one that they do not own in the Low Adult Hunters.

Horse and Rider Combination: Low Adult Amateur Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

Fence height:

Combining/Dividing Sections: The Low Adult Amateur Hunter section may be combined with the Low Children's Hunter section when there are fewer than four (4) entries in either section. - **1.00/1.05m** Amateur Jumper

Cross Entry: Competition Management may restrict cross entries between **1.10/1.15m** and **1.00/1.05m** sections at the same competition if stated in the prize list.

Rider: Riders competing in an Amateur Jumper Classic may not compete in any other Jumper Classic **above 1.15m**, Welcome Stake, Mini Prix, or Grand Prix at 1.30m or above or in the highest prize money class of any 1.30m or above section at the same show.

Horse and Rider Combination:

1.00/1.05m Amateur Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show.

Horses/Ponies: Horses and ponies exhibited in this section may cross enter multiple sections of Children's Hunter and any classes where eligible.

Fence Height:

- 3'0" with spreads not to exceed fence height
- *In and outs* will be permitted

Combining/Dividing Sections: The Children's Hunter Horse section may be divided by age of rider and/or height of fences. If the Children's Hunter Horse section is offered divided by age it will be divided: Children's Hunter Horse 14 & Under and Children's Hunter Horse 15- 17. If there are fewer than three (3) entries in either age section, the two sections must be combined. The Children's Hunter Horse section may be combined with the Children's Hunter Pony, when there are fewer than three (3) entries in either section. Classics: Children's Hunter Horse Classics

Four (4) entries are required to conduct a Children's Hunter Horse Classic. If there are fewer than Four (4) entries in any one Children's Hunter Horse Classic, it may combine with other sections of Children's Hunter Horse or Adult Amateur Hunters. If Children's Hunter Horse Classics are combined and a horse is shown in more than one section qualifying for the Children's Hunter Horse Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the Classic.

Children's Hunter Horse Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

Riders who compete in the 3' Children's Hunter Horse, Regular A Rated Pony Sections, and/or Junior Hunter 3'3" classes may show one horse in the Low Children's Hunter.

Horse and Rider Combination: Low Children's Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

Fence height:

- 2'6"

Combining/Dividing Sections: The Low Children's Hunter section may be combined with the Low Adult Amateur Hunter section when there are fewer than four (4) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Awards: Zone Horse of the Year Awards will be presented annually to the following section:

- Low Children's Hunter Horse

CHILDREN'S HUNTER PONY

Sections offered and requirements:

- Small/Medium Children's Pony
- Large Children's Pony

Cross Entry:

Rider: Rider age restrictions as found in Regular Pony sections do not apply. Riders may show only one pony in either the 2'0" or the 2'6" height of the Children's Hunter Pony section when also competing in the Regular Small, Medium or Large Pony and/or Green Pony Hunter sections. Riders cannot cross enter into any class where fences exceed 3'3" (exception: Riders may show in Pony Jumpers).

Horse/Pony: Ponies exhibiting in Children's Hunter Pony may cross enter into any class where otherwise eligible, but the rider may not show the same pony in the regular pony section. Note: The pony may only be shown by one rider in the Children's Hunter Pony Classic and that rider must be declared prior to the first round of the Classic.

Fence Height:

- Small/Medium Ponies: 2'0" with spreads not to exceed height of fence.
- Large Ponies: 2'6" with spreads not to exceed height of fence.

Combining/Dividing Sections: The Children's Hunter Pony section may be divided by size. If the Children's Hunter Pony is offered divided by size it will be divided: Children's Hunter Pony Small/Medium and Children's Hunter Pony Large. If there are fewer than three (3) entries in either height section, the two sections must be combined. The Children's Hunter Pony section may be combined with Children's Hunter Horse when there are fewer than three (3) entries in either section. A pony may only be shown by one rider in the Low Children's Hunter Pony Division. In the Low Children's Hunter Pony Classic the Classic rider must be declared prior to the first round of the Classic.

Combining/Dividing: Combining: If there are fewer than three (3) ponies in the Low Children's Hunter Pony section, they may combine with the Low Children's Hunter Horse section. If there are still fewer than three (3) entries after the Low Children's Hunter Pony section has been combined with the Low Children's Hunter Horse section, these sections may only then combine with the Low Adult Amateur Hunter Horse section.

Rider: Riders competing in a **Junior** Jumper Classic may not compete in any other Jumper Classic **above 1.15m**, Welcome Stake, Mini Prix, or Grand Prix at 1.30m or above or in the highest prize money class of any 1.30m or above section at the same show.

Horse and Rider Combination:

1.00/1.05m Junior Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show. **1.00/1.05m Junior** Jumper horse/rider combinations may enter only one classic, if both **1.00/1.05m** and **1.10/1.15m** are offered.

1.10/1.15m Junior Jumper horse/rider combinations are not permitted to cross enter into Junior Jumper classes or any class at 1.20m and above that offers prize money, at the same competition. **1.10/1.15m Junior** Jumper horse/rider combinations may enter only one classic, if both **1.00/1.05m** and **1.10/1.15m** are offered.

Fence Height:

- **Junior** Jumper 1.00m to 1.05m

Combining/Dividing Sections: Amateur Jumper sections may be divided by or combined with **Junior** Jumper sections, at management's discretion, if so stated in the prize list.

Awards: Zone Horse of the Year Awards will be presented annually to the following section:

- **1.00/1.05m Junior** Jumper section
- **1.10/1.15m Junior** Jumper section

AGE GROUP EQUITATION: CHILDREN'S/JUNIOR SECTION

Sections Offered:

- Equitation 11 & Under
- Equitation 12- 14
- Equitation 15- 17

Cross Entry: No cross entry restrictions.

Fence Height:

Equitation 11 & Under

- Minimum 2'0", maximum 2'6" - management must state height at which class will be offered.
- Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
- Course design must comply with EQ108.8 and 108.11, combinations not permitted.

Equitation 12- 14

- Minimum 2'9", maximum 3'3" - management must state height at which class will be offered.
- Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
- Course design must comply with EQ108.11 except combination is optional.

Equitation 15- 17

- Minimum 3'0", maximum 3'6" - management must state height at which class will be offered.
- Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
- Course design must comply with EQ108.11 except combination is required.
- Spreads not to exceed fence height

Combining/Dividing Sections: Age-Group Equitation Sections may be combined as necessary, jumping at their respective heights, to meet the three (3) entry minimum requirement for points to be awarded. Stallions are prohibited when adult equitation sections are combined with children's/junior equitation sections. EQ101.3.

Awards: Zone Horse of the Year Awards will be presented annually to the following sections:

- Equitation 11 & Under
- Equitation 12-14
- Equitation 15-17
